Motion by Kirkpatrick seconded by McGovern to approve the consent agenda:

Motion by McGovern seconded by Grier to approve Resolution No. 20-05-14 authorizing the issuance of \$1,600,000 General Obligation Corporate Purpose Bonds, Series 2014, and providing for the levy of taxes to pay the same. Roll call: ayes; MB, DK, AG, PM, DKubas. Motion carried.

Motion by Kirkpatrick seconded by Kubas to authorize the Mayor to sign the amended agreement with Monsanto Company to Dispose of Wastewater. All ayes. Motion carried.

Motion by McGovern seconded by Kubas to grant an extension of time until May 31, 2015 to the home owners at 104 Court Street to have their driveway in compliance with the code due to the fact that they are remodeling their home at the present time pending cooperation of the home owners keeping the rock clear of the street. All ayes. Motion carried.

Motion by Grier seconded by Bunge to approve the request from Roehrkasse Meat Company to use the sidewalk in front of their business for outside eating on June 6, 2014 for their ten year celebration. All ayes. Motion carried.

Motion by Bunge seconded by Kubas to allow Roehrkasse Meat Company to put a park bench in front of the business for seating and decoration. **Bunge withdrew the motion.**

Motion by McGovern seconded by Grier to approve to allow a movable park bench in front of Roehrkasse Meat Company as long as it remains within three feet of their business. All ayes. Motion carried.

Motion by Bunge seconded by McGovern to approve Resolution No. 21-05-14 to authorize the new City Clerk to request up to eighty hours of time at thirty dollars per hour for Jenifer Mein as a consultant at city hall after June 30, 2014. Roll call: ayes; MB, PM, DKubas, AG, DK. Motion carried.

Motion by Bunge seconded by Kirkpatrick to authorize the expenditure not to exceed \$13,000 to replace substandard sidewalks south of Oak Street along the west side of Chatham Street. All ayes. Motion carried.

Motion by McGovern seconded by Kirkpatrick to approve Resolution No. 22-05-14 to set Tanner Blomme's hourly wage at \$10.00 per hour and to hire Justin Hayes for summer help for the public work's department at a rate of \$9.00 per hour. Roll call: ayes; PM, DKubas, DK, AG, MB. Motion carried.

Motion by McGovern seconded by Grier to adjourn at 8:50 p.m. All ayes. Motion carried.
